CITATION AND INTERPRETATION

1.
 1. These regulations may be cited as: Tuition and Fees Regulations, 2020.
 2. In these regulations, unless the context otherwise requires, EDU means the institution of higher education operated by Digital Education Holdings Limited, Malta.

SCOPE AND APPLICABILITY

2.
 1. EDU charges a tuition fee from regular students, visiting students, and any other group or individual who make use of its services.
 2. The tuition and all other fees described in these regulations apply to all academic years beginning after 30 November 2020.

AMOUNTS TO BE CHARGED

3.
 1. The exact amounts to be charged as fees or tuition are regulated in Schedule 1. All payments shall be made in one instalment at the beginning of each academic year and are non-refundable.
 2. The student may ask to pay the annual tuition in three instalments before the start of each module. If such a module-wise payment plan is required, the student needs to inform the Student Affairs Team and an additional surcharge applies as regulated in Schedule 1.
 3. Schedule 1 shall be reviewed by EDU once per academic year and adjusted to changing prices and costs of the services provided. If unadjusted, the Schedule shall continue to have validity for another academic year.

FEE WAIVERS AND REDUCTIONS

4.
 1. Tuition and fees may be waived, either partially or in full, in such cases deemed by EDU to lie in its interest.

DUE DATES

5.
 1. Tuition and any other fees must be paid in full 14 days prior to the start of study and shall be transparently communicated to the student by EDU on the invoice.
 2. Access to the services EDU provides shall only be possible after the payment of the tuition fees and other fees in question are received in full.
 3. EDU may make the admission of a student to a Degree Course or to any other service it provides contingent upon proof of payment.
